D's MOTION FOR PEND LITE (filed 8/6/04)

D seeks:

- Release of \$65,000 in an escrow account
- Release of escrow funds so D can pay atty fees & other costs
- Release of escrow funds so D can pay credit card debt
- Order that P not receive funds from escrow account & further be required to pay money into said account
- GAL fees to be paid from escrow account
- Require P to pay loan that D received from his mother & pay D's atty fees for remainder of case
- Child Support stayed until case concluded
- Modification of child support

D's MOTION FOR PEND LITE (filed 8/13/04)

D seeks:

- Order that P prove her accusations that D "badgered" her and engaged in "tirades"
- Order requiring P not to file any more motions based on D's conduct
- Order that D's filed and unheard motions are to be heard before any more motion by P
- Order that P comply with all outstanding discovery requests
- Order that P pay D's atty fees and lost wages resulting from "unwarranted" motions
- Order that P cooperate with D to resolve mental health issue in a way that does not involve the Ct or attorneys

P's MOTION FOR PEND LITE (filed 8/6/04)

P seeks:

- Order that D refrain from saying, printing, or otherwise displaying or promulgating negative statements about P
- Order prohibiting D from making disparaging statements about P in the presence of the minor child
- Order prohibiting D from making denigrating statements about P in any public venue
- Atty fees
