I can no longer pay the following credit cards:

Bank One - 3655  
\$179/Month (non-payment will change rate.. 20%??)  
Wachovia - 0277  
\$179/Month (already 28%)

Of course paying the Dr. Bills or Mr Fahy bills is not a option for me.

I will be filing for bankruptcy shortly, which may result in my being fired and prevent me from taking jobs which require a security clearance in the future. I am currently on a leave of absence but unless I'm able to return by Oct 22 (which does not appear possible) I will no longer have a job anyway.

Consider this my 30 days notice of moving. Since I can't afford to pay rent I can't tell you when I will be evicted, nor can I tell you will I will go to since I can't afford to rent a new apt, and moving in with my mother isn't a real good option now that she will lose all her money (\$65,000 of her money secured the DCECU loans).

Looks like you've been pretty successful taking away my son and everything else from me. I hope you will be able to look back and feel proud of how well you have screwed the best and most loyal friend you ever had (and screwed your son in the process).

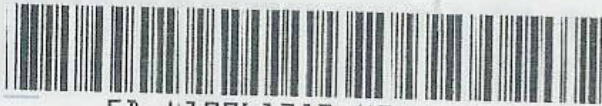
