INTRODUCTION

IX Intentional Infliction of Emotional Distress

4. In preventing the Plaintiff from attending his son's class party, in having the Plaintiff arrested, and in lying to the police, lying in court, Mr. Vanderhye acted intentionally to cause the Plaintiff Emotional Distress. The conduct of Mr. Vanderhye was so outrageous and intolerable that many people from across the country have written to the school to complain about his outrageous conduct. The court may not consider the conviction because it is under appeal.
